## **OFFICIAL CONTEST RULES**

**WALK 97.5 and WEZN 99.9 hereinafter referred to as the "Stations"**

**No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.**

### **1. Promotion Dates**

***The stations, owned and/or operated by Connoisseur Media, LLC (CONNCO) is running a promotional contest (the "Contest") from on or about September 14, 2023 at 8:55 am EDT until on or about November 17, 2023 at 9:59pm EDT (the "Promotion Dates").***

### **2. Entry / How To Win**

- a. ***Tickets will vary based on availability during the promotional period and may have varying values. Participants will be notified of ticket value upon mutual agreement to trade.***
- b. ***Thursdays September 14, 21, 28, October 5, 12, 19, 26, November 2, 10, and 17 at about 8:55 am EDT The Anna & Raven Morning Show will announce a pair of tickets available for trade.***
- c. ***Listeners must call 888.330.9999 when solicited to offer Anna & Raven an object of value in return for the tickets.***
- d. ***Station judges will choose a single contestant's item of value to "trade" for the tickets. Decisions will be made exclusively by the station judges and not be based solely on chance, skill, monetary value, comedic value, or entertainment value.***
- e. ***Contestant's Item of value MUST be exchanged in person at station studios in promised condition to be eligible to receive tickets. All applicable titles, deeds, proof of ownership, and/or provenance must be supplied at time of trade.***
- f. ***Item received by stations from contestant will be considered a donation to a charity to be named later and may be eligible for a charitable tax credit as governed by US law.***
- g. ***Tickets received by contestants will be subject to conditions in Section 4(f) herein.***
